In making this application I hereby subject myself to all the provisions of the Constitution, Bylaws, Rules and Regulations of the American Morgan Horse Association, Inc., as they now exist or may from time to time be amended, knowledge of which I now have or will immediately acquire.

ACKNOWLEDGEMENT OF ARBITRATION: I UNDERSTAND THAT THIS AGREEMENT WITH AMHA CONTAINS AN AGREEMENT TO ARBITRATE. AFTER SIGNING THIS DOCUMENT, I UNDERSTAND THAT I WILL NOT BE ABLE TO BRING A LAWSUIT CONCERNING ANY DISPUTE THAT MAY ARISE WHICH IS COVERED BY THE ARBITRATION AGREEMENT, UNLESS IT INVOLVES A QUESTION OF CONSTITUTIONAL OR CIVIL RIGHTS, INSTEAD I AGREE TO SUBMIT ANY SUCH DISPUTE TO AN IMPARTIAL ARBITRATOR.

I acknowledge that the AMHA either has made available to me, or will upon request make available to me, its Rules and Regulations. I further acknowledge that I have read and understand, or will promptly read, the Register Rules and Regulations and Rules for Hearings and Appeals of the American Morgan Horse Association, Inc. By accepting the benefits of membership in AMHA, I agree to be bound by those Rules and Regulations, including, without limitation, Rule 15, which requires a person providing false or misleading information to the Association to indemnify the Association against resulting costs and claims, Rule 16, which requires that any lawsuits or arbitration take place in the state of Vermont and binding arbitration after the Association's internal review procedures have been exhausted, and Rule 11, for Hearings and Appeals, which provides that any person who violates the Rules and Regulations or impairs the reliability of the records of the Association may be subject to sanctions.
