### USEF Competition Lite

- Shows cannot have been USEF licensed the year prior to Lite Application
- Applications must be submitted 30 days prior to the event

### Prize List

- **Entry Blank**- which must contain the rule to be signed by each exhibitor, rider, driver, and handler, coach and trainer(s), or his/her agent(s). (See GR908).
- **Officials**
  - Judge
  - Steward
  - Safety Coordinator

- Manager and Secretary
  - Farrier (must be present on grounds)
  - Vet (not on grounds but must have two names posted)
  - Medical Personnel (Qualified Medical Personnel must be on the grounds unless there is emergency service within 15 miles of the venue or cell service is available at the venue)
- **Class Specifications**- Complete class description and judging specifications for all classes offered that are not included in this Rule Book must either be included in the Prize List or referred in the Prize List to a conspicuous place on the competition's web site.
- **Statements**
    - Statement as to when and how prize money will be paid.
    - Statement concerning post entries
    - The exact date and location of competition.
    - A map and/or directions to the competition grounds.
    - For Local Competitions, the designation Local Competition must be on the cover.
    - Stabling.
    - All competitions must state the type of footing available in warm-up areas and competition arenas. The dimensions of the competition arenas must also be stated.
    - If local laws are more restrictive than the requirements of GR801 relating to protective headgear, the Licensee is required to publish the more restrictive local law (which shall control) in the prize list.
    - Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## **Morgan Competition Lite Rules**

### **Chapter 1:**

Definitions and Governance applies in its entirety.

**Chapter 2:**

Membership and Categories does not apply except for GR202.1-4 and GR203 when a competitor at a competition lite show is interested in receiving points for competing.

**Chapter 3:**

Competition Licensing does not apply except for the following:

GR302-Applications for licensing must be received by the Federation at least 30 days prior to the start of the competition. For 2018 competition year, a seven day late period will be granted on a case-by-case basis. However, under no circumstances will an application for licensing be accepted less than 21 days prior to the start of the event.

**Chapter 4:**

Drugs and Medications applies in its entirety.

**Chapter 5:**

Measurement of Entries does not apply.

**Chapter 6:**

Protest and Charges applies in its entirety.

**Chapter 7:**

Violations and Penalties applies in its entirety.

**Chapter 8:**

Conduct of Licensed Competition applies except for the following:

GR834 - GR838

**Chapter 9:**

Competition Prize Lists and Entries applies except for the following:

GR901.1, GR901.2, GR901.4, GR901.7, GR901.9, GR901.12

**Chapter 10 (and personnel in Chapter 12):**

Licensed Officials does not apply, except for the following:

1. Stewards and Judges must comply with the Federation Safe Sport Policy including the criminal background check and training requirements.
2. Steward: A person with knowledge of the discipline/breed rules to serve in this role. The Federation will give officiating credit to persons licensed or enrolled to obtain license.
3. Qualified Medical Personnel: Qualified Medical Personnel must be on the grounds unless there is emergency service within 15 miles of the venue or cell service is available at the venue. The competition organizer shall post the name and contact information for nearest emergency care facility in the area that is accessible 24 hours per day.
4. Judges: The competition must have someone designated as a judge that meets one of the following requirements: USEF licensed official or a person enrolled in the program to obtain a license/promotion; or a person with knowledge of the discipline/breed rules to serve in this role. The Federation will give officiating credit to persons licensed or enrolled to obtain license.
5. Farrier: The competition must have a farrier present at the competition.

6. Safety Coordinator: A Safety Coordinator must be designated and the manager may serve in this role; however, a Steward may not serve in this role.

7. Veterinarian: A veterinarian is not required to be on the competition grounds, however, the competition organizer shall post the name and contact information for a at least of two equine veterinarians in an area of the competition office; one of which is accessible 24 hours per day.

8. Manager: An individual acting in this capacity is required to be a Senior Active Member of the Federation. In addition, any individual acting as the manager of a hunter and/or jumper Open (not restricted to a breed) competition must be a Senior Active member in good standing of the United States Hunter Jumper Association, Inc. The competition manager of a Federation- licensed/USDF- recognized competition must be a current USDF Participating or Group member in good standing at the time competition recognition is granted and on the date of the competition.

9. Competition Secretary: An individual(s) who processes entries or performs such other duties as assigned by the Board of Directors, the Show Committee and manager. A secretary of a Dressage Competition may not serve as judge or compete as rider or handler in his/her own competition. However, he or she may show Hors de Concours if he or she designates an assistant in charge while he or she is showing. This does not absolve the secretary's duties and responsibilities. An individual acting in this capacity must be an Individual Senior Active member of The Federation.

Federation Records and Award applies in its entirety.

#### **Chapter 12:**

Competition Officials, Employees, and Volunteers applies except for the following:
