## AHA, APHC, PFHA, PShR, AMHA, ATAA, ASHBA TERMS AND CONDITIONS FOR ENTRY RELEASE WAIVER AND INDEMNIFICATION AGREEMENT

Every person or entity executing this entry form agrees and represents that: (1) the person and entity executing this entry form and the horse(s) to be exhibited by the entrant are subject to and bound by Rules of the Arabian Horse Association ("AHA"), the Appaloosa Horse Club ("ApHC"), the Paso Fino Horse Association ("PFHA"), the Performance Shagya-Arabian Registry ("PShR"), the American Morgan Horse Association ("AMHA"), the Akhal-Teke Association of America ("ATAA"), the American Saddlebred Horse and Breeders Association ("ASHBA") and the rules of the entity or entities that are responsible for organizing and conducting the event (the "Ride"); (2) that every horse, rider, driver and handler is eligible as entered; (3) that the entrant and any of his representatives agree to accept as final the decision of any applicable hearing committee authorized by AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA on any question arising under AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA and the Ride, as applicable; (4) that permission to enter a horse and the rental of any storage, stall, or tack space, if granted, shall not create a bailment between AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Regions (Region 10) or the clubs, the facilities leased by "the Ride" (Huntersville Hundred Ride Site) and state wherein held (Minnesota), and the entrant or others and, at all times, horse and any other property belonging to or accompanying the entrant shall be under the care, custody, control and supervision of the entrant; (5) the entrant agrees to fully indemnify and hold harmless AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA the Regions (Region 10), the Ride, the facilities leased by "the Ride" (Huntersville Hundred Ride Site) and the state wherein held (Minnesota), and their agents, employees, contractors, officials, officers, directors, successors and assigns from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations, including, but not limited to, any and all attorneys' fees, of whatsoever kind and nature which may be incurred by or asserted against any of them as a result of any act, failure to act, or neglect by the entrant, his agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or by any animal owned by, accompanying or exhibited by the entrant; (6) the parties executing this entry form, for themselves, their heirs, executors, administrators, successors and assigns release and forever discharge AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Regions (Region 10), the facilities leased by "the Ride" (Huntersville Hundred Ride Site) and the state wherein held (Minnesota), and the Club, their officials, officers, directors, agents, employees, contractors, successors and assigns from any and all rights and claims for any damage, loss or injury to themselves, other persons, horses or other property belonging to them to the fullest extent permitted by law arising out of or relating in any way to the Ride and participation in the Ride including, but not limited to, damages resulting from or due in whole or in part to any acts, failure to act, negligence or neglect of other entrants, AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Region (Region 10), the facilities leased by "the Ride" (Huntersville Hundred Ride Site) and state wherein held (Minnesota), and the club, or their agents, employees, officials, officers, directors, contractors or invitees, as well as for theft vandalism, fire, other casualty damage, or damage arising out of any defects in the premises; (7) the entrant acknowledges that AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event and grants AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA the right to make use of any photographs, films or videotapes taken of the below entered horse(s) and riders/drivers/handlers while on the grounds or in transit between the stabling facilities and the event site, in any way they see fit in the promotion of the Ride, AHA, ApHC, PFHA, PShR, AMHA, ATAA and ASHBA. No such advertising or promotional rights shall include the right to use a participant's name or likeness in a manner which implies endorsement of any company, product or product category, or service; (8) if AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA in its sole discretion, deems that circumstances have arisen which require cancellation of the Ride in its entirety, or cancellation of any particular event during the Ride, then all applicable fees shall be refunded in full, but AHA, ApHC, PFHA, PShR, AMHA, ATAA and ASHBA shall not be liable or otherwise responsible to the parties executing this form or any of their representatives for any costs, damages or expenses resulting directly or indirectly from such cancellation.
