REGISTRAR'S REPORT

Real data on Morgan breeding activity.

The Registry Department and the Morgan horse has continued to see growth throughout 2021. The staff was increased to three full time positions, which included Erica Eulau, Registrar, Susan Steward, Registry Associate, and Lisa Duncan, Registry Coordinator. They handled 10,425 transactions, compared to 8,442 in 2020. This does not reflect additional paperwork that is processed without money, such as castration and death reports.

Registrations continued to remain strong in 2021 with 2,110 Morgan horses registered ranging in foaling years from 1992 through 2021, up approximately 13 percent from 2020 and up approximately 21 percent from 2019. This was only 20 fewer Morgan horses as projected in October 2021 and 360 more registrations than estimated in the 2021 budget.

Of the 2,110 Morgans registered in 2021, 930 were 2021 foals, 766 were 2020 foals, 180 were 2019 foals, 82 were 2018 foals, 47 were 2017 foals, 30 were 2016 foals, seven were 2015 foals, 13 were foaled in 2014, eight were foaled in 2013, nine were foaled in 2012, six were foaled in 2011, eight were foaled in 2010, six were foaled in 2008, three were foaled in 2007, five were foaled in 2006, and one was foaled in 2004, 2003, 2002, and 1992.

The Registry transferred 3,626 Morgan horses, up approximately 18 percent from 2020 and up approximately 28.5 percent from 2019. This was 82 fewer transfers than projected in October 2021 and 626 more transfers than estimated in the 2021 budget. Transfer statistics are based on when the certificate is printed/ mailed from the office, not when the transfer was recorded with the registry.

As of December 31, 2021, there were 609 registration applications pending completion. Of these, 399 are for 2021 foals, 101 are for 2020 foals, 40 are for 2019 foals, and 69 are for horses foaled in 2018 and prior. These figures are by the year foaled, not by when they were received. At the same time last year there were 403 applications pending completion.

The Registry continues to handle many requests for DNA kits to identify owners beloved horses. If a DNA type is on file, the lab will find a match. If a match is not found, staff will work with the lab to determine if a sire/dam qualification can be found. This test does not guarantee registration and/or transfer, however the staff will do all they can to assist in the process. AMHA DNA testing does not determine breed.

To approve that the Sale or Disposal without a Registration Certificate; Non-Registration fee be \$100.

To approve that there be no reinstatement fee for Morgans sold or disposed without registration certificate or as non-registerable.

To approve that the registration fee for a 501(c)(3) Rescue organization be no more than \$50 plus DNA testing and transfer fees, and the horse must be transferred into the ownership of the Rescue.

RGAN BREEDING ACTIVITY AS OF 4/6/2021 STALLIONS/MARES BRED

Ctallion Service Reports for 629 stallions have been processed to date. This compares with 557 Stallion Service Reports that had been processed at this time in 2020, representing an increase of approximately 13 percent. Last year we saw a decrease of approximately 1.4 percent from the prior year.

2,601 mares were reported bred, compared to 2,377 mares at this time in 2020. This represents an increase of approximately 9.4 percent. Last year we saw an increase of approximately 1.93 percent from the prior year.

When comparing the percentage of mares bred with foals registered from 2014 through 2018, the average percentage of mares with resulting registered foals is approximately 64 percent. Last year, the average of mares bred with registered foals from 2013 through 2017 was approximately 64 percent as well.

FOAL CROP

Over the last five years, the average percentage of foals registered for the preceding year, at the time the reports were run, was approximately 74 percent.

For instance, as of April 6, 2021, there were 1,601 registered Morgans foaled in 2019, compared with 1,199 registered Morgans foaled in 2019 registered as of April 7, 2020.

Many are concerned when they see the annual foal crop statistics. However, these numbers increase as more registrations are received annually.

Another way to forecast the foal crop would be to base it from the average of mares bred with resulting foals as outlined above, which is currently approximately 64 percent of mares bred.
