

Amanda Hill Young Breeders Incentive Grant Process and Application

The Amanda Hill Young Breeders Grant celebrates the memory of Amanda Hill and her connection with the equine industry. Amanda was a long time Morgan owner, exhibitor, and breeder whose passion for the Morgan horse was highlighted in her volunteer work across the Morgan industry. Amanda was instrumental in the establishment of AMHA's Young Adult Alliance and was a strong supporter of the annual Morgan Stallion Sweeps held at the New England Morgan Horse Show. Combining these two passions, this grant was created in Amanda's name to ensure her work and passion for the Morgan industry lives on in the areas where her personal connection ran deep.

The Amanda Hill Young Breeders Incentive Grant is designed to help young Morgan breeders achieve their breeding dreams. It may be awarded annually to a young AMHA member (under the age of 40) who is establishing a breeding program intended to strengthen the quality of the Morgan breed. Amanda had a vision that recognized the need for younger generations to continue these breeding programs so that the love of the Morgan horse could be shared from generation to generation.

The grant application period for this year's grant (2023) will close at the end of the day (5:00 PM ET) on Monday, June 19, 2023.

Inquiries about grant applications or the grant process are only handled by email. Kindly email execdir@morganhorse.com with any questions or comments, and you will receive a response promptly.

Upon submission, you will receive an email at the address provided in the application as verification that your application has been received. If you do not receive such an e-mail, please contact us. Of paramount importance in the analysis of applications each year is that they be need-based and means-tested applications (defined on page 2), and value-based applications. Please note these in your application.

All grant recipients must agree to expenditure responsibility disclosures. As part of those requirements, recipients will need to transmit a written summary of the activities (expenses) that the grant funded within 45 days of expending the funds. That summary must also include a spreadsheet detailing how and to whom the funds were allocated. The expenditure responsibility requirements dictate as well that evidence be provided that the grant allocation was made for its intended purpose. This requirement can be met in the form of photos, testimonials or otherwise.

Thank you for your interest in applying for the Amanda Hill Young Breeders Incentive Grant and particularly for your commitment to Morgan horses and equestrian sport.

QUESTIONS

Am I eligible to apply for a grant?

Grants may be awarded to any AMHA young adult member (under the age of 40 years old).

How is the grant money distributed?

Checks may be made payable to the business providing the service (expense) or reimbursed to the grant recipient when submitted to AMHECT and accompanied by the <u>original</u> receipt.

How much funding does AMHECT generally give to grant recipients?

The Trustees will determine in advance of the application period the amount awarded in any given year based on availability of funds, etc. The grant amount for this year will be \$2,500.

When can I expect to learn if I am selected?

The grant review committee meets to consider grants during the same month as the deadline and expects to announce its decisions in the following month. However, the trustees reserve the right to alter the timeline. All applicants, including those not approved for funding, will be notified of the Board's decisions.

What does means-tested mean?

"Means-tested" wording refers to determining need as a principal criterion in awarding grants. The committee also weighs the benefits of the program/endeavor against the proposed budget to ensure the greatest value for the funding allocated.

What types of expenses can the grant cover?

The grant can be used for expenses related to (but not necessarily limited to), stud fees, mare lease fees, semen shipping costs, vet services related to proposed breeding endeavors, futurity nomination payments, DNA and registration expenses, etc.

Does AMHECT accept multi-year proposals, or should applications be limited to a project in a certain year?

AMHECT will consider all proposals submitted and applicants may submit proposals in subsequent years.

How do we go about writing a compelling grant?

- 3. Detailed budget of the program including anticipated dates of expenses.
- 4. Current or alternate sources of funding besides this possible grant (where will the funds come from that pay for the remaining expenses, etc.).
- 5. How you hope to impact the Morgan industry with your breeding program.

Please note that part of the selection process is based on your initiative, presentation, and professionalism of this application. Your submission should be a minimum of one page but a maximum of 2 pages with a 12-point font or smaller, a maximum of 1-inch margins, and single spaced.
