REGISTRATION APPLICATION

CHECK LIST

To expedite processing the following should be in order:

- You must provide three name choices.
- A stallion report must be on file.
- Mare owner(s) or Lessee(s) must sign Section 6.
- Draw and describe all markings in pen.
- If the horse has no markings, check the box on the diagram.
- Both Sire and Dam must have DNA on file.
- Enclose your registration fees.

Directions are listed in the left hand column.
 Please read all directions carefully before filling out the information.

INSTRUCTIONS:

A. Registry Application: Except in the case of an Embryo Transfer foal, the record owner (or lessee) of the dam at the time of the foaling is responsible for the registration of the foal and will be listed on the registration certificate as the foal's first owner.

B. If the foal being registered is an Embryo Transfer, and Embryo Transfer Application may be required. Rule 2, Section 6.

C. Make checks and money orders payable to: American Morgan Horse Association®.
 Fee must accompany the application. To pay by credit card, see back page.

D. Print in ink or type only.

 -identifies presence and dosage (1 or 2 copies) of cream dilution gene.
- Lethal White Overo**
 -identifies carriers of lethal white foal syndrome.
- Red Factor and Agouti**
 -defines the base coat colors of chestnut, bay, black.
 -identifies homozygous black or carriers of red (chestnut) pigment.
- Sabino 1**
 -identifies presence and dosage (1 or 2 copies) of Sabino 1 gene, one of the genes responsible for white spotting.
- Silver**
 -identifies presence and dosage (1 or 2 copies) of the Silver gene that dilutes only black pigment.
- Gray**
 -identifies presence and dosage (1 or 2 copies) for the Gray gene.
- Splash**
 -Splashed white is a variable white spotting pattern characterized primarily by extremely large blaze, extended white markings in legs, variable white spotting in belly, and often blue eyes.
- Dun**
 -identifies presence and dosage (1 or 2 copies) of the Dun gene.
- Dominant White Pattern Test**
 -identifies the W5, W10, and W20 mutations for owners who want to breed horses for Dominant White or to determine the genetic status of horses with unknown white patterns.

Mane, tail, and legs are not black, but are the color of the body or shades lighter or darker. Dark chestnuts may look black with the exception of red hairs on the coronet, pasterns, and/or back of fetlocks. <input type="checkbox"/> Black: true black without any light areas. <input type="checkbox"/> Bay: shades from reddish tan to dark mahogany brown. Black mane and tail, and black below the knees and hocks. <input type="checkbox"/> Brown: black with light mealy areas at muzzle, eyes, flanks, and inside of legs. <input type="checkbox"/> Palomino: shades of very pale creamy yellow to golden yellow, with flaxen, silver, or white mane and tail. <input type="checkbox"/> Buckskin: tan to yellow, with black mane tail and lower legs. Buckskins without the dun gene may appear to have a dorsal line, but this is countershading, not a true dorsal stripe. <input type="checkbox"/> Smoky Black: varying shades of black. May appear to have a black or brown body. Can be difficult to distinguish from black, dun, chestnut, or brown. <input type="checkbox"/> Cremello: ivory colored coat in shades from very light to darker cream color. Mane and tail are ivory or flaxen. Light pinkish skin and blue or bluish green eyes. <input type="checkbox"/> Perlino: ivory colored coat in shades from very light to darker cream color. Mane and tail may be slightly darker than body. Light pinkish skin and blue or bluish green eyes. Points may be darker than its body. <input type="checkbox"/> Smoky Cream: ivory colored coat, with or without black overtones. Smoky cream is produced by the action of two cream dilution genes on a black base.

- Outline all of the markings of the horse being registered.
- Complete the diagrams with the horse in front of you. Do not trust your memory or hearsay.
- Include any scars or brands the horse may have that might be helpful in identifying the horse.
- Clear photographs of the markings may help speed processing, especially for horses that have unusual markings.
- Mark the location of the forehead cowlick(s) (hair whorl) with an X. Indicate accurately if to the right/left or above/below the guidelines. This step **MUST** be completed for all horses with no white markings.

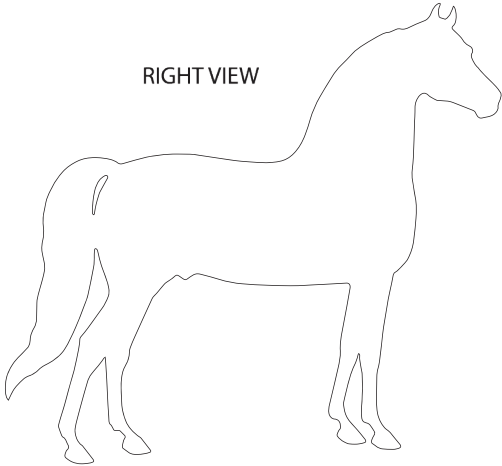
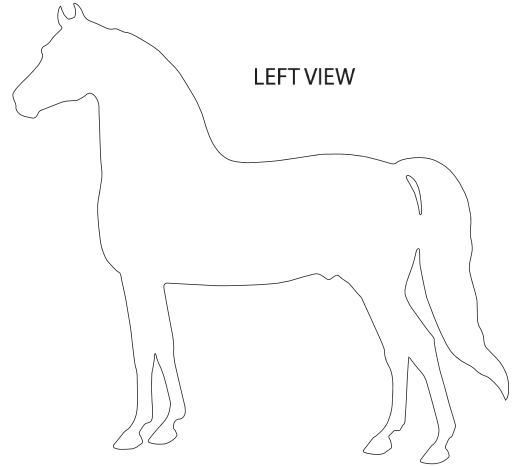


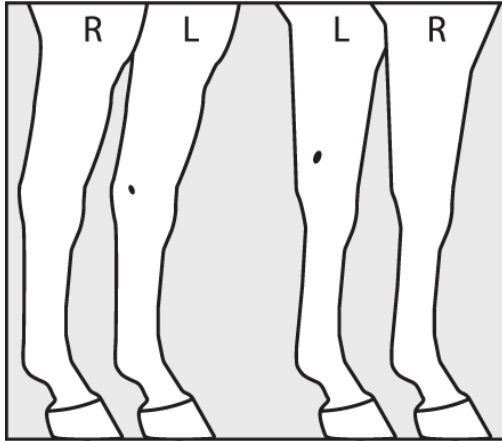
DIAGRAM ALL MARKINGS AS THEY CURRENTLY APPEAR

~ MARKS & CHARACTERISTICS DEFINITIONS ~

Star—A white mark on the forehead, located above the line running from eye to eye. • **Strip**—A white marking extending from the line of the eyes toward the line running nostril to nostril. • **Snip**—A white or flesh mark between the nostrils or on the upper or lower lip. • **Blaze**—A star and stripe combined that is more than half as wide as the face at eye level and includes both nostrils. • **Bald Face**—A wide blaze that extends to or around the eyes or nostrils, with most of the upper lip also being white. • **Heel**—A white marking found on the back of the foot. • **Coronet**—A white marking extending to approximately 1" above the hoof. • **Pastern**—A white marking extending to the top of the pastern. • **Fetlock**—A white marking extending to the top of the fetlock (ankle). • **Sock**—A white marking extending to midway on the cannon. • **Stocking**—A white marking extending above midway on the cannon. • **Spots**—Pigmented spots located within white. • **Roan Spots**—Areas of white hairs mixed into the basic coat color that does not have underlying light-colored skin. • **Ben dór Spots**—Randomly distributed small to large spots or color that range from a couple of shades darker than the base coat to almost black.
