RULES and **FEES**

RULE 6: TRANSFER OF RECORD OF OWNERSHIP

- A. An official Transfer Application must be correctly completed and submitted to the Registry with the appropriate fee upon every change of ownership of the registered horse.
- B. Any person applying for transfer of a horse may be required to furnish (at the applicant's expense) blood type reports or DNA analysis reports, other additional information, documentary, or evidence the Registry may deem appropriate.
- C. The official Registration Certificate for the horse being transferred must be submitted with the application for transfer.
- D. For the purpose of transfer, the membership status of the person (buyer or seller) submitting the Transfer Application determines the fee. Member rates may be applied to the transfer of all Morgan horses sold at consignment auctions of-fering registered Morgan horses provided:
 - 1: more than 50 registered Morgans are catalogued;
 - 2: the sale manager is a current AMHA member, and,
 - 3: a fee of \$100 is paid by the sales management per auction.
- E. Whenever legal title of a registered horse passes to another person by reason of death of the recorded owner, foreclosure of any lien, by any order or decree of court, or otherwise by operation of law, the Registry may transfer the registration of the subject horse to the new owner:
 - 1: Upon court order of competent jurisdiction or other satisfactory proof of authority for the transfer.
 - 2: Upon payment of the transfer fee.
 - 3: Upon satisfaction of such other requirements as may be required by the Executive Director or the Registrar.

TRANSFER FEES

Either the buyer's account OR the seller's account needs to be a current AMHA member for the member fee to apply.
